### Method of payment:

- By Standing Order:** Complete the Standing Order mandate below and send it to YOUR BANK.
- By cheque/cash:** Cheques, made payable to the 'South Yare Wildlife Group', should be posted to the SYWG Secretary at the address above. Cash should be handed directly to a SYWG committee member. DO NOT POST CASH.

We must have your explicit consent to record your personal information including your name and email address. The information we record will be kept securely and will only be used to maintain our membership records and administer activities where this information is required. Individual member's details will not be shared with other organisations and data will not be sent outside of the UK. Your details will be kept for no longer than two years after your last payment or consent, and then deleted.
